2. We will not include details or full names (which means first name **and** surname) of any child in an image on video, on our website, or in printed publications, without good reason. We may include the full name of a competition prize winner if we have their consent. However, we will not include the full name of a child used in promotional literature.
3. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video or on our website or in printed publications.
4. If we use images of individual pupils, we will not use the name of that child in the accompanying text or photo caption without good reason. And if a pupil is named in the text, we will not use a photograph of that pupil to accompany the article without good reason.
